1. I, the undersigned participant, being eighteen (18) years or older, or the legal guardian of a participant under the age of eighteen (18) years old, in consideration of services rendered by Mt. Hood Bicycle, LLC, do hereby waive on my behalf and that of my heirs, any and all claims, causes of actions, or demands of any kind against Mt. Hood Bicycle, LLC, its employees, officers, and agents for any injuries, death, illness, or material loss that may occur from participation by myself and those under my legal guardianship in any activities let, guided, or instructed by Mt. Hood Bicycle, LLC officers, agents and/or employees.
2. I understand that recreational endeavors such as road biking, mountain biking, skiing, hiking, rafting and fishing are by nature inherently dangerous and that with each of these activities there is a risk of injury or death. I understand and agree that for the duration of the above mentioned activity, I am fully responsible for my health and safety, as well as the health and safety of the above mentioned minor under my legal guardianship. I accept and assume all responsibility for injury, death, or property damage arising from participation in these activities.

3. My participation with Mt. Hood Bicycle, LLC is purely voluntary, and I elect to do so in spite of the risks. These risks include, but are not limited to bad road conditions, motor vehicles, rugged and remote conditions, primitive trails, rocky ground, cliffs, steep grades, vertical exposure, sharp turns, weather conditions creating slippery roads and trails, lighting, and risk of exposure, illness due to dehydration, heat exhaustion, hypothermia, fatigue, animal bites, bees, wasps, etc.
4. I understand and acknowledge that no medical benefits will be provided to me during this event. I certify that I, or those under my guardianship, are in good physical condition and have no maladies or underlying injuries that impair motor skills, endurance, or could hinder or effect in any way emergency medical attention. I have no allergies to bee stings, animals, plants, or any substance I may come into contact with at any time during this event. I carry personal accident insurance sufficient to cover property damage and/or bodily injury that may occur to myself, or any of the above mentioned minor under my legal guardianship, or I am fully capable of personally paying for any and all such expenses or liability. I understand that I am fully responsible for search and rescue charges should the need arise during this event.
5. _____ (Initial) I have inspected the rental equipment prior to using it and deem it safe for use. I warrant that I have received instruction in the safe and proper use of the bicycle and equipment I am about to use. I hereby state that I understand how to use the brakes and shifting mechanisms on the rental bicycle I am about to use. I understand that rental bicycles are equipped for daytime use only, and any use of the bicycle after dark is at my own risk.
6. I accept full responsibility for any loss or damage to rental equipment beyond normal wear. I understand that upon return of rental equipment, damages assessed by Mt. Hood Bicycle, LLC to be caused by negligence, accident, or abuse requires immediate payment in full to cover replacement parts and labor. I further agree that any adjustments performed by myself on said equipment are subject to readjustment by Mt. Hood Bicycle, LLC at my expense.
7. ***I am aware of the following conditions on bicycle rental and ride cancellation policies:*** All rental fees and tour fees are to be paid in advance. Rental bicycles must be returned immediately after completion of each daily ride/tour. All deposits and fees are non-refundable unless it is due to poor weather conditions. Absolutely no refunds for no-shows or late arrivals. There are no refunds for cancellation of any ride/tours for any reason except for weather conditions. All decisions regarding weather cancellations are to be made by Mt. Hood Bicycle, LLC staff only. There is a 50% refund on vacation and multi-day packages if cancelled 30 days or more prior to your trip date with Mt. Hood Bicycle, LLC.

You may purchase cancellation insurance from a local travel agent to cover loss of monies due to cancellation.
